Ordinary Resolutions

Resolution 1

To receive the audited annual accounts of the Company for the year ended 31 December 2022 together with the Director's reports, strategic report and the Auditor's report on those annual accounts.

Resolution 2

THAT PKF Littlejohn LLP be re-appointed as the Auditor of the Company, to hold office from the conclusion of this AGM to the conclusion of the next General Meeting at which accounts are laid before the Company.

Resolution 3

THAT the Directors be authorised to determine the remuneration of the Auditor.

Resolution 4

THAT Naheed Memon be re-appointed a Director of the Company in accordance with Article 24.2(a) of the Company's Articles of Association.

Resolution 5

THAT, the Directors be and they are hereby generally and unconditionally authorised in accordance with section 551 of the Companies Act 2006 (the 2006 Act) to exercise all powers of the Company to allot shares in the Company and to grant rights to subscribe for, or to convert any security into, shares in the Company up to an aggregate nominal amount of £2,690,675.48 but subject to such exclusions or other arrangements as the Directors may consider necessary or appropriate to deal with fractional entitlements, treasury shares, record dates, or legal, regulatory or practical difficulties which may arise under the laws of, or the requirements of any regulatory body or stock exchange in any territory or any other matter whatsoever, provided that this authority shall expire on 30 June 2024 or, if earlier, the date of the Company's next AGM, save that, prior to its expiry, the Company may make offers or enter into agreements which would or might require shares to be allotted or rights to be granted after such expiry and the Directors shall be entitled to allot shares or grant rights to subscribe for or convert any security into shares in the Company pursuant to any such offer or agreement as if this authority had not expired, and all unexercised authorities previously granted to the Directors to allot shares, or grant rights to subscribe for or convert any security into shares in the Company be and are hereby revoked.

THAT subject to the passing of Resolution 5 pursuant to and in accordance with sections 570 and 573 of the 2006 Act, the Directors be and are generally and unconditionally authorised to allot equity securities (as defined in section 560(1) of the 2006 Act) wholly for cash under the authority given by Resolution 5 and/or by way of a sale of treasury shares as if section 561(1) of the 2006 Act did not apply to any such allotment (or sale), such authority to be limited to an allotment of equity securities (or sale of treasury shares) up to an aggregate nominal amount of £1,277,246.09 and to be issued solely in connection with an election by a debt holder to convert interest payments to shares in respect of the Company's Luxembourg listed EUR 22.5m 10.0% secured notes as set out in the announcement to the Market on 3 March 2022, such authority to expire on 30 June 2024, or if earlier, the date of the Company's next AGM (unless renewed, varied or revoked by the Company prior to its expiry), save that, prior to its expiry, the Company may make offers or enter into agreements which would, or might, require equity securities to be allotted (and treasury shares to be sold) after such expiry and the Directors may allot equity securities (and sell treasury shares) under any such offer or agreement as if such authority had not expired.

Resolution 7

Notes

1. Pursuant to regulation 41 of the Uncertificated Securities Regulations 2001, the Company specifies that in order to have the right to attend and vote at the AGM (and also for the purpose of determining how many votes a person entitled to attend and vote may cast), a person must be entered on the register of members of the Company no later than close of business on the day that is two days before the time for holding the meeting or any adjournment of it (excluding non-working days). Changes to entries on the register of members after this time shall be disregarded in determining the rights of any person to attend or vote at the meeting.
2. Only holders of ordinary shares are entitled to attend and vote at this meeting.

A member is entitled to appoint another person as his proxy to exercise all or any of his rights to attend, to speak and to vote at the AGM. A member may appoint more than one proxy in relation to the meeting, provided that each proxy is appointed to exercise the rights attached to a different share or shares held by him. A proxy need not be a member of the Company.

You will not have received a hard copy proxy form for the 2023 AGM in the post. You can instead submit your proxy vote electronically by accessing the shareholder portal at www.signalshares.com, logging in and selecting the 'Vote Online Now' link. You will require your username and password in order to log in and vote. If you have forgotten your username or password you can request a reminder via the shareholder portal. CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s), should refer to their CREST sponsor or voting service provider(s), who will be able to take the appropriate action on their behalf.

In order for a proxy appointment or instruction made using the CREST service to be valid, the appropriate CREST message (a "CREST Proxy Instruction") must be properly authenticated in accordance with Euroclear UK and International Limited's ("Euroclear") specifications and must contain the information required for such instructions, as described in the CREST Manual. The message, regardless of whether it constitutes the appointment of a proxy or an amendment to the instruction given to a previously appointed proxy, must, in order to be valid, be transmitted so as to be received by the issuer's agent (ID: RA10) by the latest time(s) for receipt of proxy appointments specified in the notice of the AGM. 4. Any corporation which is a member can appoint one or more corporate representatives who may exercise on its behalf all of its powers as a member provided that they do not do so in relation to the same shares.
5. Any member attending the AGM has the right to ask questions. The Company must cause to be answered any such question relating to the business being dealt with at the meeting but no such answer need be given if (a) to do so would interfere unduly with the preparation for the meeting or involve the disclosure of confidential information, (b) the answer has already been given on a website in the form of an answer to a question, or (c) it is undesirable in the interests of the Company or the good order of the meeting that the question be answered.
6. As at 19 May 2023 (being the last practicable date prior to the publication of this notice) the Company's issued share capital consists of 2,826,858,784 ordinary shares of 0.1p each, carrying one vote each. No shares are held in treasury. Therefore, the total voting rights in the Company as at that date are 2,826,858,784.

Explanatory Notes

1. Resolution 1. At the AGM, the Directors will present the annual accounts, together with the Directors' report, Strategic report and the Auditor's report on the accounts, to the shareholders for the financial year ended 31 December 2022.
2. Resolution 2. This resolution concerns the re-appointment of PKF Littlejohn LLP as the Auditor until the conclusion of the next General Meeting at which accounts are laid.
3. Resolution 3. This resolution authorises the Directors to fix the Auditor's remuneration.
4. Resolution 4. This resolution is in respect of the re-election of Naheed Memon who stands for re-election in accordance with the Company's Articles of Association.
5. Resolution 5. This resolution deals with the Directors' annual authority to allot Relevant Securities in accordance with section 551 of the 2006 Act. If passed, the resolution will authorise the Directors to allot ordinary shares or to grant rights to subscribe for or to convert any security into shares up to a maximum nominal amount of £2,690,675.48. The authority granted by this resolution will expire on 30 June 2024 or, if earlier, on the conclusion of next year's AGM, save in relation to offers or agreements made prior thereto which would or might require the issue or grant of shares or rights after such date.

6. Resolution 6. This special resolution 6 will, if passed, give the Directors power, pursuant to the authority to allot granted by resolution 5, to allot equity securities (as defined by section 560(1) of the 2006 Act) or sell treasury shares for cash without first offering them to existing shareholders in proportion to their existing holdings up to a maximum nominal amount of £1,277,246.09 which authority may be used solely in connection with an election by a debt holder to convert interest payments into shares in respect of the Company's Luxembourg listed EUR 22.5m 10.0% secured notes.

As announced on 3 March 2022, the Company's Luxembourg listed EUR 22.5m 10.0% secured notes (the "Notes") have now been restructured and all cash interest payments on the Notes accruing from 12 April 2022 can, at the election of the Noteholder, be taken in shares in respect of the interest accrued in the immediate preceding quarter. Resolution 5 seeks the disapplication of pre-emption rights for use in an Interest Conversion Event only. The exact number of shares will vary depending on the election of the Noteholders and the share price at the time of issue but the Company has estimated this to be up to a maximum of 1,277,246,094 shares.

7. Resolution 7. This resolution will, if passed, give the Directors power, pursuant to the authority to allot granted by resolution 5 to allot equity securities (as defined by section 560(1) of the 2006 Act) or sell treasury shares for cash without first offering them to existing shareholders in proportion to their existing holdings: (a) in relation to pre-emptive offers and offers to holders of other equity securities if required by the rights of those securities; and (b) in any other case, up to a maximum nominal amount of £1,413,429.39. The power granted by this resolution will expire on the conclusion of next year's AGM or, if earlier, on 30 June 2024, save in relation to offers or agreements made prior thereto which would or might require the issue or grant of shares or rights after such date.
